5-day Duke University Spirituality and Health Research Workshop

Full Scholarships

(for promising faculty and graduate students in developing countries)

With funding from the John Templeton Foundation, we are pleased to announce the 2020-2022 Templeton Scholarship Program designed to assist international faculty/students from economically disadvantaged area of the world to attend our 5-day Duke University Spirituality and Health Research Workshop on August 10-14, 2020. The competitions will also be held in 2021 and 2022 for the workshops held in those years. This Duke University workshop compresses into 5 days the material previously presented in our 2-year post-doctoral Duke University fellowship, and is the only place in the world where specific training on how to conduct research on religion, spirituality and health can be obtained from researchers active in the field for more than 35 years. In 2020, this will be the 17th year the workshop is being offered, with nearly 900 attendees in past years, many of whom have become academic leaders in the field of spirituality and health (for more information about the workshop and past attendees, see https://spiritualityandhealth.duke.edu/index.php/5-day-summer-research-course).

In 2020, we are offering 11 Scholarships (\$3600 each) for researchers, university faculty, graduate students, undergraduate students, and key decision-makers in developing countries and economically-disadvantaged areas of the world. Each scholarship will cover:

- (1) Full cost of workshop tuition plus individual mentorship¹ plus a 500-page syllabus (\$1200)
- (2) Economy class roundtrip airfare (\$1500 or less)
- (3) Seven nights of lodging in modest accommodations (total cost \$500 or less)
- (4) Reimbursement for meals and expenses related to local transportation to and from workshop (total cost \$400 or less)
- (5) Eligibility to win a \$1000 bonus (for the most productive scholar during the 3-year program)

The costs above (1-4) must add up to no more than \$3,600 (the maximum value of each scholarship).

We expect these scholarships to be highly competitive.

Eligibility criteria include the following (all 1-8 must be completed):

1. Residence in a developing country (http://www.ssr.org/DevelopingCountries) or an economically-disadvantaged area of the world, including Africa, South or Central America, Mexico, Asia, Middle East (depending on country), Russia, and Eastern Europe. Residents from other areas of the world considered "developed" (including China, Russia, India, Brazil, etc.) may qualify depending on socioeconomic status of region & quality of applicant. Passport from that country (scanned copy of main passport page emailed to Dr. Koenig at Harold.Koenig@duke.edu) is required for proof of residence.

¹ Scholarship recipients will have an individual 30-minute mentorship session with Dr. Koenig and possibly with other workshop faculty (depending on availability).

- 2. Scanned copy of valid U.S. visa emailed to Dr. Koenig. If needed, we will provide a letter of invitation to facilitate this process after reviewing the completed application for applicants who are competitive. If you are seriously interested in applying for this scholarship, please immediately begin the process of obtaining a US visa, which can take 6-9 months or longer to obtain. The final decision on the scholarship will not be made until proof that a US visa has been obtained.
- 3. Proof of university faculty appointment, graduate or undergraduate student status, or position in government, healthcare system, national media, or funding institution. A signed letter from the university administration (or government body or other institution) on official letterhead will be required for documentation (scanned and included in email specified in #7 below to Dr. Koenig).
- 4. Applicant is in a position to conduct research and, preferably, has a history of conducting and publishing research, and is specifically interested in doing research on religion, spirituality and health. This will be judged based on applicant's Personal Statement and resume (curriculum vitae).
- 5. Fluency in the English language (workshop presenters speak English only). At least one letters of recommendation (below) must state this fact.

INSTRUCTIONS (follow carefully)

- 6. Completion of **Scholarship Application** as follows:
- (a) A *Personal Statement* that describes personal and professional reasons for wishing to attend the Spirituality and Health Workshop (2 pages single-spaced maximum);
- (b) A preliminary *Research Proposal* with (1) background for study, (2) specific aims, (3) hypotheses, (4) research methods (type of study, characteristics of sample, description of questionnaire or intervention, statistical methods), (5) timeline of project activities, (6) plan to obtain funding support for the study, (7) if funding obtained and research completed, plans to publish the findings in peer-review journal and disseminate findings to the general public through the media, and (8) references cited in the proposal. The research proposal should be limited to 5 pages single spaced, Times Roman size 12 font, 1-inch margins.
- (c) *Future Plans* in terms of practical use of the information learned during the workshop should be described (e.g., plans to conduct research, apply for grant funding to support research, teach at university level, apply to clinical practice, advocate for public policy changes at the national level, dissemination of research on spirituality and health to the general public through the media, etc.) (1-page single-spaced maximum).
 - (d) Three scanned letters of recommendation e-mailed to Dr. Koenig (including #3 above).
- (e) Curriculum vitae (resume) with publications, grants, training, current position, prior academic positions, etc.

7. Read carefully:

FIRST, a single MS-word document containing (a), (b), (c), and (e) above; **SECOND**, the three scanned PDFs of letters of recommendation in (d) above, and the letter demonstrating proof of university faculty appointment, graduate or undergraduate student status, or position in government, healthcare system, national media, or funding institution (#3 above); **THIRD**, the signed statement in #8 below -- all should be sent in a <u>single email</u> as attachments to <u>Harold.Koenig@duke.edu</u>. Failure to do this will result in rejection of your application.

8. Signed statement indicating that applicant has (a) financial hardship and could not attend the workshop without the scholarship; (b) will attend all 5 days of the workshop and complete preand post-workshop assessments; and (c) will complete a post-workshop assessment of accomplishments 1 year after attending the workshop. This document should be signed, scanned, and an included as an attachment in the email to Dr. Koenig described in #7 above.

Scholarship Winners

The following individuals are encouraged to apply (in order of likelihood of being awarded a scholarship):

- (1) university faculty in the health or social sciences with a history of prior research and publications;
- (2) university faculty in the health or social sciences with interest in research on spirituality and health and potential to conduct it;
- (3) university faculty more generally (e.g., in theology, healthcare administration, public policy) who may be well-known and influential in their institution and in a position to teach or to influence the institution's policies and priorities with regard to research on this subject;
- (4) promising post-doctoral students with strong recommendations, history of conducting research, or potential for conducting research in this subject area;
- (5) healthcare system administrators in key positions who may help in the dissemination of the research and facilitate its integration into clinical practice;
- (6) public policy makers and persons in key government or funding agency positions that may influence the conducting of research on spirituality and health;
- (7) promising undergraduate students with strong recommendations, interest in and potential for conducting research in this subject area;
- (8) health professionals, particularly physicians in key positions, who may facilitate the conducting of research and its application to clinical practice;
- (9) clergy in key positions in religious denominations who may facilitate the conducting of research or support of research on spirituality and health and dissemination to members of their denomination;
- (10) individuals with educational media skills with a background in the health sciences who have the potential to develop education programs on spirituality and health, or individuals in the popular media who have considerable influence in terms of dissemination to the general public.

Those receiving a scholarship will work directly with our travel agent who will arrange for economy class airfare. Lodging will be arranged directly by our Duke University Center. Payments will be made directly to the travel agency and hotel. For miscellaneous travel expenses while here in the U.S., i.e., meals and local transportation to and from the workshop

(expected to be less than \$400, depending on other travel costs), original receipts will need to be turned in to Dr. Koenig for reimbursement.

Miscellaneous Information

This workshop has been previously approved for 32.5 continuing medical education credits from Duke University School of Medicine, and while it currently provides no CME or CEU, many attendees have gotten their certifying bodies to approve the course for CME/CEU based on the course syllabus and prior approval. No formal degree is being offered for those who complete the workshop, other than a certificate of completion provided by Duke University's Center for Spirituality, Theology and Health, and signed by Dr. Koenig.
